Cape Coral has almost 4,000 acres of land available for commercial development and growth. Our excellent infrastructure and strategic location support countless business opportunities. Two Foreign Trade Zones (FTZs) allow businesses to import parts and components duty free if they use them to manufacture or assemble products for export.

Tax incentives in Cape Coral include:

- No** personal income tax
- No** corporate income tax on limited partnerships
- No** corporate income tax on S-corporations
- No** corporate franchise on capital stock
- No** state-level property tax assessment
- No** property tax on business inventories
- No** property tax on goods manufactured or produced in Florida for export outside the state
- No** sales tax on purchases of raw materials incorporated in a final product for resale, including non-reusable containers or packaging
